Circle L Foster Guidelines

1. Only designated CIRCLE L staff shall approve and place rescued animals into foster homes. Your Foster Coordinator must be notified as soon as possible of any changes in the status of either the animal in your care or the foster home environment you have indicated above.
2. All animals placed in foster care will be examined by a CIRCLE L veterinarian, and will have been given/will be given all necessary immunizations, and either already or will be scheduled to be spayed or neutered.
3. All basic medical and general expenses will be covered by CIRCLE L. Approved CIRCLE L staff must approve any unusual expenses. Basics include: Spay/neuter, age-appropriate vaccinations, heartworm test, FeIV/FIV test, microchip, and prescribed medications.
4. A CIRCLE L foster dog must wear his/her ID Tag at all times (except underage puppies who do not go home with collars), and must be on a leash or in a secure pet carrier when outside of its foster home or its enclosed yard. During transport, the rescued animal must ride inside a crate inside of the vehicle. A CIRCLE L foster cat must live indoors only with any outdoor access in a safe, enclosed environment.
5. Your Foster Coordinator must be notified immediately if an animal in your care is injured or missing.
6. Legal ownership of all CIRCLE L animals remains with CIRCLE L until such time as proper adoption is completed. No rescued animal may be adopted, transferred, or relinquished without approval by authorized staff of CIRCLE L.
7. Only authorized representatives of CIRCLE L will conduct adoption interviews and process adoptions.
8. Adoptions will be deemed consummated only after completion of the Adoption Contract, receipt of the adoption fee, and final approval by the authorized representative of CIRCLE L.
9. All veterinary care is performed at CIRCLE L authorized veterinarian staff. Charges for care must be approved prior to receiving care. CIRCLE L reserves the right to identify the type of care needed and whether it is in the best interest of the animal to proceed with such care.
10. Any care received that is not authorized by CIRCLE L will be at the cost of the individual foster parent. Discuss all care with your CIRCLE L foster contact to obtain necessary authorization.
